THE TWO-HOUR BREAK IN BETWEEN IS DESIGNED TO GIVE VENDORS A BREAK. THEY CAN STAY AT CCBLOOM DURING THIS TIME, OR LEAVE AND COME BACK.
- OUR RECEIPT OF YOUR VENDOR APPLICATION DOES NOT GUARANTEE ACCEPTANCE.
- WE ACCEPT VENDOR PAYMENTS THROUGH OUR SECURE E-ECOMMERCE SHOP ONLY. ONCE AN APPLICATION IS ACCEPTED, AN EMAIL WITH THE LINK TO THE E-COMMERCE SHOP WILL BE SENT TO THE VENDOR, AT WHICH POINT THE VENDOR HAS 72 HOURS TO PAY.
